Valid for booking from the 1st January 2012 until further notice.

Liability and Insurance

1. All participants must be in good health. We do need to be informed at time of booking and on arrival at the centre if a non-swimmer is participating.
2. All participants must be aware of the potential hazards involved in all activities and accept the risks associated.
3. Bear Creek Adventure Ltd is under no liability whatsoever in respect of injury, death, loss, damage to property/ personal belongings.
4. Participants are most strongly advised to arrange their own suitable insurance cover. Bear Creek Adventure Ltd is unable to offer any form of insurance cover (other than public liability).
5. All participants must be aware that any loss or damage to Bear Creek Adventure Ltd & Edgbaston Watersports property (including facilities used) & equipment will be invoiced to the individual at cost for repair/ replacement under the discretion of the Company Directors.

Health and Safety Considerations

1. Due to strenuous nature of some activities, all participants should be physically fit. Anyone with medical conditions must seek medical advice and contact us.
2. Course participants will not be permitted to consume alcohol or drugs prior to or during courses. Bear Creek Adventure Ltd staff reserve the right to refuse anyone considered being under the influence of drugs or alcohol.

Disabilities
